**From NJ Turnpike**

Take Exit 10

Follow Sign for 440 North towards Perth Amboy/Garden State Parkway/Staten Island

Take Smith St. Exit and follow sign for Smith St.

Continue on Smith St. (Approx. 1-2 miles) to Bertrand Ave. (1 way St.)

Right Turn on Bertrand Ave. go 1 block to Market St.

Left on Market St. Go 1 ½ blocks to Olive St.

Right turn on Olive Street, Building will be in front of you, go through gate to rear of building for parking

**From South Via US Hwy 9 N**

Take ramp for 440 North toward Smith St./Perth Amboy

Continue on Smith St. (Approx. 1-2 miles) to Bertrand Ave. (1 way St.)

Right Turn on Bertrand Ave. go 1 block to Market St.

Left on Market St. Go 1 ½ blocks to Olive St.

Right turn on Olive Street, Building will be in front of you, go through gate to rear of building for parking

### **From North Via US 9 S**

Take ramp **right** for **CR-656 / Smith St East** toward **Perth Amboy / Keasbey** 1.5 mi

Take Smith St. Exit and follow sign for Smith St.

Continue on Smith St. (Approx. 1-2 miles) to Bertrand Ave. (1 way St.)

Right Turn on Bertrand Ave. go 1 block to Market St.

Left on Market St. Go 1 ½ blocks to Olive St.

Right turn on Olive Street, Building will be in front of you, go through gate to rear of building for parking

### **From North Via Garden State Parkway S**

Take exit 129 towards Route 9 South. Continue on Rt. 9 South to Smith St. exit.

Take Smith St. Exit and follow sign for Smith St.

Continue on Smith St. (Approx. 1-2 miles) to Bertrand Ave. (1 way St.)

Right Turn on Bertrand Ave. go 1 block to Market St.

Left on Market St. Go 1 ½ blocks to Olive St.

Right turn on Olive Street, Building will be in front of you, go through gate to rear of building for parking

### **From South Via Garden State Parkway North**

Take exit 125 towards Sayreville/South Amboy

Bear right onto Hwy 35 North

Continue on Hwy 35 N crossing over tall bridge. At 1<sup>st</sup> light after crossing the bridge, make a right turn onto Smith St.

Continue on Smith St. (Approx. 1-2 miles) to Bertrand Ave. (1 way St.)

Right Turn on Bertrand Ave. go 1 block to Market St.

Left on Market St. Go 1 ½ blocks to Olive St.

Right turn on Olive Street, Building will be in front of you, go through gate to rear of building for parking
